DTV Consumer Education Quarterly Activity Report

Instructions

Stations are required to air PSAs or crawls at various times in any given day part, and at least one PSA and one crawl per day must be run during primetime hours. On-air education must not contain inaccurate or misleading statements and must be provided in the same language as a majority of the programming carried by the station. PSAs must be at least 15 seconds, and closed-captioned. Crawls must run during programming for no fewer than 60 consecutive seconds across the bottom or top of the viewing area (See rules for additional details).

From 1/1/09 through 2/10/09 WLOS ran the following PSA: ""Notice how digital's made pretty much everything better? Especially television. Digital TV's got better picture, better sound, more channels--- In fact, digital's so much better that, by law, ALL broadcast TV has to be digital by 2009. But there's a catch: Some TV's need an upgrade to get digital. You could even lose your signal. Get the facts. Visit DTVAnswers.com to learn about television's switch to digital. Or call this number to see how you can stay connected." From 2/11/09 through 3/31/09, WLOS ran the following PSA: "By now, you've heard that antenna TV is going all digital. And the nationwide switch to digital TV has moved to a new date: June 12. But you don't have to wait until June 12 to enjoy free digital television. Upgrade your antenna TV with a converter box or buy a new digital set. Use the right antenna, and start enjoying free digital TV now. Visit tvanswers.com or call 888-CALL-FCC to learn more about the June 12 switch to digital TV." In addition to the PSA's, WLOS also ran the following crawl: "Attention: Full Power Analog Broadcasting will end on February 17, 2009 and Analog only television sets may not be able to receive the signal of this station after that date unless viewers take action. Over-the-air viewing on an analog-only TV will require the use of a converter box. Analog TV's should continue to work with cable and satellite providers, VCR's, DVD players and similar products.
